

Association of Chartered Certified Accountant (ACCA) is a leading global professional accounting body which offers Global Chartered Accountancy qualification (ACCA or FCCA). Chartered Wealth Manager (CWM) is a specialist qualification introduced by Chartered Institute for Securities and Investments (CISI) for professional, which will aid them to demonstrate their competence in devising investment portfolios that meet clients' needs. A member of ACCA will have to appear for only 2 professional level exams (exempting them from all foundation level exams and I professional level exam) to become a Chartered Wealth Manager (CWM).


